### Summary Points

#### Access and volume

- Students need to read widely and wildly.
- Teachers need to know students and books to match readers to texts effectively.

#### Response to text

- Students need time and space to think, talk, and write about texts.
- Effective question to ask students: “What are you thinking about this text?”

#### Explicit instruction

- Unlocking the mystery behind reading for students is so important. This can be effectively done through think alouds that model the use of strategies.

#### Purpose

- Teachers need to be sure instruction and assignments align with what real readers and writers do.

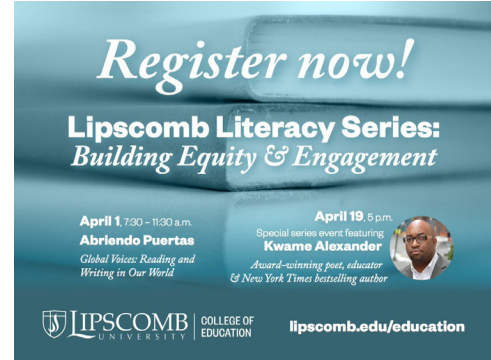
