Summary Points

What do we mean by collaboration?

- Co-laboring together
- Coming together of ideas
- > Meshing work contributions to create something even better

How do we hold individual students accountable for group work?

- > Include individual accountability as well as group accountability
- Group size is key
- Triangulate assessments group work rubric (self, each team member)
- Design meaningful tasks challenging, engaging, stimulating, and multilayered
- > Students need a reason to collaborate (other than a grade)
- Model individual accountability while working in collaborative groups.
